2023 RAA Board Election competition - Terms and Conditions

General

- 1. Information on how to enter and prize details form a part of the competition terms and conditions of entry (**Terms and Conditions**).
- 2. Entry into the 2023 RAA Board Election competition (**Competition**) is deemed acceptance of the Terms and Conditions.
- 3. The Promoter is Royal Automobile Association of South Australia Incorporated, of 101 Richmond Road, Mile End SA 5031, ABN 90 020 001 807 and available by phone on (08) 8202 4600 (RAA or Promoter).
- 4. The Competition commences at 9:00am ACST on 9 August 2023 and closes at 5:00pm ACST on 13 October 2023 (**Promotion Period**).

Eligibility & How to Enter

- 5. Entry to the Competition is open to Eligible Members of RAA (as determined by the RAA Constitution) as at 1 August 2023 who are entitled to vote in the 2023 Board Election (Eligible Member) for which a ballot is being held between 9 August 2023 and 13 October 2023 to elect candidates to fill two vacancies on the RAA Board of Directors (2023 Board Election).
- 6. All employees and immediate family members of employees of the Promoter and its related bodies corporate are ineligible to enter. Immediate family means any of the following: spouse, de facto spouse, child or step child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, brother, sister, step-brother or stepsister.
- 7. To enter the Competition, Eligible Members must vote in the 2023 Board Election either by:
 - Lodging a ballot using the Promoter's online voting portal votingservices.com.au/raaballot2023 by 5:00pm ACST on 13 October 2023; or
 - Lodging a paper ballot form which is received by the Returning Officer of the Promoter by 5:00pm ACST on 13 October 2023 (Entrant).
- 8. By voting in the 2023 Board Election, Entrants will be automatically entered into the Competition. If an Entrant would not like to take part in the Competition, they must contact the Promotor via email to **companysecretary@raa.com.au** at least five (5) days prior to the draw taking place.
- 9. Only one valid entry per Entrant.



- 10. Entries not completed in accordance with these Terms and Conditions or received after the Promotion Period ends will not be considered. Incomplete, fraudulent or incomprehensible entries will be disregarded. The Promoter accepts no responsibility for late, lost or misdirected entries.
- 11. The Promoter reserves the right, at any time, to verify the validity of Competition entries and Entrants (including an Entrant's identity and place of residence but not their votes cast in the 2023 Board Election) and to disqualify any Entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 12. If there is a dispute as to the identity of an Entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Entrant.

Prizes & Draw

- 13. The prize draw consists of physical RAA branded EFTPOS gift cards, with 10 prize draws taking place valued at \$500 each.

The list will only comprise of information already held by RAA and will not include details of the votes cast in the 2023 Board Election.

If the Competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify the Entrant; or (b) subject to any written directions from a regulatory authority, modify, suspend, terminate or cancel the Competition, as appropriate.

- 23. The Promoter handles personal information in accordance with the *Privacy Act 1988* (Cth), including the Australian Privacy Principles, and will deal with personal information in accordance with its privacy policy.
- 24. By entering into the Competition Entrants acknowledge that the Promoter may use the personal information it already holds for Entrants to conduct the Competition and Entrants agree to be bound by the Promoter's privacy policy.
