

RAA Drive School '1 Year Free Standard Road Service' and 'Gift Voucher' Promotion - Terms and Conditions

1. Information on eligibility and details of the promotion form part of these Terms and Conditions.
2. The purchase of any RAA Drive School lesson pack, including the 1, 3, 5 or 10 RAA Drive School lesson pack ("**Promotion**") is deemed to be an acceptance of these Terms and Conditions and entitles the purchaser ("**Student**") to receive 12 months of free Standard Level of RAA Road Service and Gift Vouchers upon successful completion of their final driving test (VORT) or final logbook task (Task30).
3. The promoter is the Royal Automobile Association of South Australia Limited (ACN 677 371 274) (ABN 90 020 001 807) of 101 Richmond Rd, Mile End, SA 5031 (**RAA**).
4. The Promotion is effective as from 1 May 2026 and finishes on 30 June 2027 unless extended or withdrawn earlier in RAA's sole discretion ("**Promotion Period**").
5. To be eligible for the Promotion, the individual must:
 - a. be 16 years of age and over;
 - b. be a resident of South Australia;
 - c. purchase of a VORT driving lessons or logbook driving lessons with RAA Drive School;
 - d. hold a current South Australian learner's permit at the time of purchase;
 - e. be a new client of RAA Drive School (i.e. not have previously purchased RAA Drive School lessons)
 - f. not be an existing RAA Road Service member at the time of redemption; and
 - g. pass their final driving lesson (VORT) or final task (task 30) for the logbook system.
6. The promotion consists of the following for each eligible Student (valued at a total of \$188.00 (AUD) per entrant):
 - a. x1 Restaurant e-voucher valued at \$20.00;
 - b. x1 Fuel e-voucher valued at \$20.00;
 - c. x1 Repco e-voucher valued at \$20.00;
 - d. x1 Trev Keyring Valued at \$2.00

 ("**Gift Voucher**"), and
 - e. 12 months of RAA's Standard Level of Personal Road Service for free (currently valued at \$126.00) and:

- i. is subject to the terms, conditions and entitlements set out in RAA's Personal Road Service Entitlements Guide (available from [Our Road Service Entitlements Guides | RAA](#)), the [RAA Constitution](#) and [Membership Terms and Conditions](#) which govern the terms and conditions of RAA Membership;
 - ii. applies to Personal Road Service only;
 - iii. is for Standard Level of Personal Road Service cover only; and
 - iv. is free of charge for a 12 month period only commencing upon the successful completion and passing of either the VORT driving lesson or the final task (Task 30) in the logbook system. RAA will automatically apply Standard Road Service to the membership holder's account at this time — no claim or redemption is required by the membership holder
7. To qualify for the promotion, the Road Service product must be established in the name of the learner driver registered with the RAA Drive School to participate in the lesson(s) only. The promotion will not apply when immediate road service is required at the time of booking the package (i.e. Join on Service).
8. Redemption is limited to one per Student. For the avoidance of doubt, a membership holder is entitled to one instance of 12 months free Standard Road Service, which will be automatically applied by RAA upon completion of RAA Drive School lessons and the subsequent passing of their final driving test or assessment. This entitlement is available regardless of whether the membership holder later purchases additional lessons for use by a different learner driver, and may only be redeemed once per person.
9. Gift Vouchers will be issued by RAA electronically and will be sent to the email of the eligible Student registered with RAA Drive School following successful completion and passing of either the VORT driving lesson or the final task (Task 30) in the logbook system.
10. At the completion of the 12 months of free Standard Road Service period, an invitation will be sent to the Standard Road Service product holder to renew the product for a further 12 month period at the product holder's expense should the product holder wish to continue.
11. This promotion does not apply to Premium or Plus levels of RAA Personal Road Service. To upgrade from Standard Road Service, the membership holder must pay the difference between the annual fee for their current membership and the annual fee for either Plus Road Service or Premium Road Service.
12. This promotion is not redeemable for cash or valid in conjunction with any other offer unless specified other than RAA's member loyalty savings and multipolicy discount* (if applicable).
13. RAA is not responsible for Gift Vouchers that are undelivered, lost, or delayed due to incorrect contact details provided by the Student.

14. Gift Vouchers are redeemable at participating retailers as specified on the voucher. Redemption is subject to the terms and conditions imposed by the relevant individual retailer and any conditions printed on or accompanying the Gift Voucher. Refer to the relevant provider's website for terms and conditions.
15. Gift Vouchers have an expiry date as specified on the voucher. RAA accepts no responsibility for Gift Vouchers that are not redeemed prior to the expiry date. Expired Gift Vouchers will not be reissued or replaced.
16. RAA reserves the right to cease any offer that has been made as part of the promotion, and withdraw, amend or substitute a Gift Voucher of equal or greater value at any time, without notice.
17. RAA shall not be liable for any personal injury, property damage or other loss or damage whatsoever (including but not limited to direct or consequential loss) suffered or sustained in connection with this promotion, except for any liability which cannot be excluded by law.
18. RAA shall not be liable for any loss, damage, or disappointment suffered as a result of a Gift Voucher being lost, stolen, damaged, or destroyed after delivery to the student, except for any liability which cannot be excluded by law.
